First-Time Exam Applicants Must Obtain FCC Registration Number before Taking Exam

Beginning May 20, 2021, all amateur examination applicants will be required to provide an FCC Registration Number (FRN) to the Volunteer Examiners (VEs) before taking an amateur exam. This is necessary due to changes the FCC has made to its licensing system.

Amateur candidates who already have an FCC license, whether for amateur radio or in another service, already have an FRN and can use the same number. All prospective new FCC licensees, however, will be required to obtain an FRN before the examination and provide that number to the volunteer examiners on the Form 605 license application. An FCC instructional video provides step-by-step instructions on how to obtain an FRN through the FCC's COmmission REgistration System (CORES).

The video is available at, https://www.fcc.gov/rofrn.

The FRN is required for all new applicants to take an amateur exam and is used afterward by the applicant to download the license document from the FCC Universal Licensing System (ULS), upgrade the license, apply for a vanity call sign, and to submit administrative updates (such as address and email changes) and renewal applications.

In addition, after June 29, all applications will be required to contain an email address for FCC correspondence. Applicants will receive an email direct from the FCC with a link to the official electronic copy of their license whenever a license is issued or changed. ARRL VEC suggests that those without access to email to use the email address of a family member or friend. Licensees will be able to log in to the ULS using their FRN and password to download the latest version of their license at any time. The FCC no longer provides paper license documents.







PARC Fleamarket Notes for Club Meeting April 22, 2021

We chairs have made the decision to host a flea market again this year. Because of social distancing, we are moving it to the North Bend City Auditorium. We will encourage the wearing of masks, but it will be it the decision of each person present. We can still accommodate the same number of vendors and the silent auction, all in one space, which has been a concern in the past with some vendors. There will be more space for social distancing in the aisles, etc. It is well lit, air conditioned, and handicapped accessible. Vendors will access the building from the north and the south at 7:30 am to set up. The front doors will open at 9 a.m. for other hams. If another ham comes with a vendor, we will let them in to help. The rent is somewhat more than in the past at \$200. This compares to the \$50 and extra \$50 we usually gave St. Charles as an additional donation. However, at the auditorium we give them our floor plan, which we have already sketched out and they will set up all their tables for us, take them down, and do the cleaning. We will take out the trash and be responsible for the extra tables we had to rent like in 2019. We will have to set up and rent a sound system, unless a PARC ham knows of the availability of one for free use or a donation.

Darlene has indicated that she would like to step down from the major responsibility of heading the Diner. It will be her decision if we keep the name or choose a new one. We have members ready to take her place, and a menu is already being organized similar to what we did in the past. Servings will be prepared according to COVID recommendations. Coffee and tea will again be our treat to all in attendance. We will need volunteers to help serve in the kitchen as in the past. We will be celebrating our 80th year as planned last year with decorated cupcakes for everyone.

We are requesting to buy only one larger prize from our funds to celebrate. Because of the request for a larger door prize, we are suggesting \$1 per extra ticket or 6 for \$5. We are suggesting a larger prize for these reasons:

- To encourage a good attendance base.
- To celebrate our 80th anniversary.
- We did not spend anything last year, so want to contribute a little more this year.

We have looked at purchasing an Icom 718 HF 10 - 160 meters 100 watt transceiver radio for a cost of \$575 plus tax from Gigaparts.com. It will take two to four weeks to ship.

We are suggesting to increase our general admission to \$3.00 a person, and the price per table be increased to \$6 a table. This is still the cheapest flea market around. With the transition to the auditorium, this is a good time to ask for a slightly higher donation as we have never asked for an increase in 20 years. This will still include a free chance for the raffles.

We will again use the coaster wagons. We have four nice ones already to go, two for each entrance. As in the past, we will need members to man the doors and tables
